

Wondering about enrollment for School Year 2018-2019?

If you have a student already attending UP this year and intend to attend UP or MIS next year your student will simply roll up to the next grade! You do **NOT** need to go online to enroll your child as your child is already enrolled! *We will simply send home a paper confirmation form in Feb. and ask that you send that back to us.*

If you are enrolling a sibling of a student currently attending any campus within HPISD, keep reading for your instructions.

1. IF you have a sibling of a student currently enrolled and attending school at any HPISD campus, you will log in to Skyward Family Access and on the top left you should see a button that says: "Enroll a New Student". If you do not see this button, email Paula richarp@hpsid.org to correct this. (the person that is listed first in the guardian list from parents during Back to School Sign UP or online enrollment, has the option but 2nd guardian listed does not – we can flip flop this easily) After completing enrollment through Skyward you are able to turn in your paperwork for your incoming student the week prior to round up. Starting on Tuesday, Feb. 20th through Friday Feb. 23rd (from 7:30-2:30 pm daily) we will accept your **completed** packet in the main office here at UP. (*packets will not be accepted after 2:30 pm on any day*) Your packet will be date and time stamped upon rcpt. There is no need to attend New Student Round UP if you qualify to turn your packet in early.

We will only accept complete packets. Incomplete packets will not be accepted at any time.

ALL items are required on new students enrolling, we do not pull items from siblings packets.

If you are completely new to UP and do NOT have a student enrolled now or in the past in the district, keep reading for your instructions.

2. Your first step is to complete online enrollment. Go to www.hpsid.org and click on the parent section. Then click on "Enroll a New Student". **Be sure you choose school year 2018-2019!** The start date for the upcoming school year is August 23rd. Once you complete this online enrollment, the system will prompt you to print some of the pages. Please print those pages in order to turn in a complete packet. One of these pages is a checklist of items that must be brought to the school to complete enrollment. These items will include the following:
 - a. *Warranty deed OR HUD statement OR Settlement Statement OR Closing statement on your home OR Lease (each document must be in its entirety)*
 - b. *Current water OR electric bill*
 - c. *Driver's license with the home address*
 - d. *Immunization record (student)*
 - e. *Birth Certificate (student)*
 - f. *Social Security card (student)*

Completed packets will be brought to the New Student Round UP on Feb. 27th at 9:00 am at UP.

We will date and time stamp the completed packets at that time. After turning in your packet there will be a brief meeting in the UP cafeteria starting around 9:30.
